of the Delhi School Education Act & Rules, 1975.

Sir,

With reference to your application on the subject noted above, I am directed to convey the permission of Director of Education, Delhi to your society to start a new school in the East District in Prest Nagar from Class I to 12 subject to the following terms and conditions:

1. That the provision of the DSEA, 1975 and Rules framed thereunder shall be observed by the society.
2. That the Management of the school will fulfill all the conditions laid down under Rule 50 and provide all the facilities given in rules 51 of DSEA, 75 to the institution.
3. That the management of the school will get the scheme of management approved from the Department immediately.
4. That only qualified and trained teachers will be appointed and prescribed Govt. scales along with all allowances will be paid to the teaching and non-teaching staff through crossed cheques.
5. That the management of the school will not ask for Grant-in-aid from the Department.
6. That the school will not run for the profit of any individual association or group of persons.
7. That in case at any time the management of the school is unable to run the school, movable and non-movable property of the school will be transferred in the name of the Director of Education, Delhi.

8. That the management of the school will apply for grant of recognition of the school under DSEA & Rules, 1973 separately and recognition will not be granted unless statutory provision of section 4(i) (a-f) read with rules 50 & 51 are fulfilled.
9. That all the recognised classes shall be run at one place only.
10. That the management of the school will obtain land from DDA in the name of the society for the proposed school through Directorate of Education, Delhi.
11. That the proposed school will be managed under the banner of the Preet Vihar Education Society, Delhi (Regd.) and suitable funds for the purchase of land as well as construction of suitable building thereon as per the specification of the department will be transferred from the funds of Preet Nagar Cooperative House Building Society to the Education Society as required under the Delhi School Education Act & Rules, 1973.
12. That the proposed school should be started only after the allotment of the land as well as construction of proper school building as per the specification of the Department within a period of three years from the date of issue of this letter (S.O) and adequate and sufficient accommodation @ 12 sq. ft. per student shall be provided for class rooms. The normal size of a classroom is 24' x 20'.

If recognition for the proposed school is not sought after fulfilling the above conditions within a period of three years, this permission to open a new school shall be treated as cancelled.
