subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi  
School Education Act & Rules, 1973 framed thereunder as  
well as the instructions issued from time to time.
2. That the school shall admit students without any discr  
mination of caste and creed and preference shall be given  
to the students of Prest Vihar area.
3. That the school shall appoint more full-time qualified  
and eligible staff for all the classes of the school as  
per the present norms of the department.
4. That the school shall equip the Science Lab. as per  
the norms of the department and suitable facilities  
for practical work shall be provided to the students.  
Rs. 5000/- (Five thousand) shall be provided during 1987-88.

books worth Rs. 5000/- (Five thousand) may be  
added and facilities of reading room may also be  
provided during 1987-88.

16. That the management of the school shall create a Reserve Fund of Rs. 5000/- (Rupees five thousand) only in a joint account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
17. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school and class IX shall not be opened without the prior approval of the Director of Education, Delhi.
18. That the school society shall apply for the allotment of land and will construct the building as per the specifications of the Directorate of Education, Delhi within a period of three years.
19. That the management of the school shall provide all the facilities as per rule 50 and all conditions as required under Rule 51 shall be complied with.
20. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled, shall be sent to the Education Officer every six months.
