1. NAME OF THE SOCIETY: The name of the Society shall be  
**THE PREET VIHAR EDUCATION SOCIETY, DELHI.**

2. REGISTERED OFFICE: The Registered Office of the Society shall be situated in the Union Territory of Delhi and at present it is at the following address:  
**X/343, KATRA HUDA RAI, INSIDE DELHI GATE, DARYAGANJ, NEW DELHI.**

3. AIMS AND OBJECTS: The aims and objects for which this society is established, are as follows:

- a) To spread education among the children of the members of the Society and the General Public.
- b) To open Schools, Colleges and Library for the achievement of the above objects.
- c) To construct, demolish or alter any building which may be necessary convenient for its purpose.
- d) To purchase, take or accept as a gift or otherwise acquire any real or personal property or privileges thereto attaching which may be necessary or convenient for its purpose.
- e) To sell, exchange or transfer for consideration or by way of gifts all or any portion of its properties, assets and liabilities.
- f) To get aid from the concerned Government Authority/authorities.
- g) All income of the Society shall be utilised for the achievement of the above object.

4. GOVERNING BODY: The names, addresses, occupations and designations of the present members of the Governing Body to whom the management of the Society are entrusted as required under section 2 of the Societies Registration Act of 1860 (Punjab Amendment Act, 1957) as extended to the Union Territory of the Delhi.

STATUTORY AND REGULATIONS OF PREET VIHAR EDUCATION SOCIETY.

DELHI

1. Membership: The membership of the Society shall be open to all the persons without discrimination of caste, colour and creed but subject to the approval of Managing Committee.
2. Subscription: Subscription shall be as follows:
  - a) Admission Fee Rs.25/-
  - b) Subscription Rs. 5/- per month
  - c) Life member shall pay Rs.100/- once only.
3. Termination of Membership: The Managing Committee shall have the power to expel the member from the Society on the following events:
  - a) if he has not paid his monthly subscription for more than three months;
  - b) if he has not attended three meetings of the Society without any justification;
  - c) on his written resignation.
4. Appeals: All the appeals should be sent to the Managing Committee of the Society. Decision of the Managing Committee will be final. The reason for rejection shall be communicated to the person concerned.
5. Re-admission: Every member who has been expelled by the Managing Committee, he can be re-admitted provided he pays all upto-date dues alongwith Rs.25/- as Re-admission fee.
6. Bank Account: The Bank Account of the Society shall be operated by any two office bearers from Chairman, Secretary and Treasurer.
7. Management of Funds: All income of the Society shall be deposited in the Bank.
8. General Body: It shall consist of all members of above category and described in membership clause above.
9. Functions of General Body:
  - a) To prepare, introduce, supervise and amend curricular, syllabi and other programme regarding the ducation of pupils. To create teaching, administrative technical, ministerial and other posts under the Society and to make appointments, terminations, promotions and transfers therto and arrange training for them.
  - b) To lease or let on hire all or any portion of its

properties, assets and liabilities to any other Society, person or persons.

c) To buy, sell, endorse, negotiate or transfer all Government or other securities and to collect and realise interest or bonus, dividends or profits on such securities for the advancement of the purposes of the Society.

d) To invest its funds and moneys in Securities or properties upon such terms and conditions as may be deemed expedient and to operate its accounts with any Bank or Bankers etc.

e) To amalgamate, associate or cooperate with any other Society or institution having objects in whole or in part, similar to those of this Society.

f) To do all such other acts and things as may be incidental and necessary to the attainment of its objects.

g) To get lands on lease basis for setting up Higher Secondary School/Primary and Nursery Schools left for the specific object of the education of the children.

h) To consider any business brought forward by the Managing Committee;

i) There shall be an annual meeting of the general body every year;

j) At least 15 days notice shall be given to the members before the date of general body meeting enclosing the agenda specifying date, time and place.

10. Election: The general body in its annual meeting will elect its office bearers and members except Chairman every year by raising of hands or by secret ballot paper and the quorum of the general body and managing committee shall be 2/3rd. The Chairman will hold office for life time. He can only be removed on no-confidence vote of 2/3rd majority of the general body or he dies.

11. Source of Income:

a) Admission fee

b) Donations

c) Subscription and special contributions

12. Managing Committee: The strength of the Managing Committee shall be not less than seven members and not more than eleven members including office-bearers.

13. Functions of Managing Committee:

a) to arrange finance if required from other Banks, Institutions or individuals on <sup>for the better Education of the children</sup> terms and

and conditions and the Managing Committee as a whole is liable for its return.

- i.) the Managing Committee shall be responsible for implementation of the decision taken by the general body and to make plan for the future programs of the Society;
- ii.) to appoint, terminate and fix duties of any staff;
- iii.) the Managing Committee shall meet atleast once in a month for which three days notice will be issued to all the members.

14. Powers and duties of office bearers:

- a) Chairman: He will be the head of the Society and preside over the meetings of general body and managing committee. He will have the right of casting vote in case of tie.
- b) Vice-Chairman: In the ~~absence of~~ <sup>case of</sup> Chairman the Vice-Chairman shall act in his place.
- c) Secretary: Powers of the Secretary are as under:
  - i) to sign on behalf of the Society and to conduct its correspondence and ~~conduct~~ the proceedings of such meetings;
  - ii) to summon and attend general meetings of the Society;
  - iii) to call ordinary general meeting if desired on the written request of atleast 25 members;
- d) Treasurer: To keep accounts of all receipts and expenditures to the Society and to furnish necessary informations to the Managing Committee. He will keep Rs.200/- with him and the balance amount will have to be deposited in the Bank.

15. Audit: The accounts of the Society shall be audited atleast once a year by an auditor appointed by the general body, or by the Managing Committee.

16. Financial year: The financial year of the Managing Committee shall be from 1st April to 31st March every year.

17. Tenure: The terms of the Managing Committee shall be five years.

18. Necessary provisions of the act:-

- a) Every year a list of managing committee members shall be filed with the ~~Government~~ <sup>Central Government</sup> ~~Society Rego~~ <sup>Regd</sup> Registrar of Societies as per section

  - .) Any amendment in rules or memorandum shall be made as per section 12 and 12A of the Act.
  - .) The Society shall be dissolved as per section 13 & 14 of the Societies Registration Act.
